DECLARATION OF CONSENT

BEFORE USING THE KAHLENBERG ARCHERY COURSE, THE FOLLOWING RULES MUST BE OBSERVED:

- Use of the facility and the shooting range is only permitted to archers with a valid day or annual pass. These must be carried on the course and presented upon request.
- Every archer is required to sign the course book before starting and after completing the course.
- The use of a crossbow is NOT permitted!
- Children and young people under the age of 18 may only use the shooting range and the course if accompanied by an adult or instructor.
- Persons using the area without authorization or without registration will be charged an increased daily fee of €50 and may be reported.
- Smoking is strictly prohibited in the forest (fire hazard).
- Persons under the influence of alcohol are prohibited from shooting.
- Sturdy, closed-toe shoes with a treaded sole are required to use the course.
- Each shooter is responsible for their own shot. This means that each shooter must ensure that the shooting line and the danger zone behind it are clear before firing to ensure that neither people nor animals are endangered.
- Only one person will shoot at each station in the course. All other people in a group must stand behind the shooter when firing.
- Dogs must be kept on a leash!
- The course may only be used in the designated direction.
- At dusk, during thunderstorms, heavy rain, storms, or in heavy fog, shooting must be stopped immediately!
- Shooting is only permitted from the shooting pegs and the designated areas.
- Red Stake - Sight Shooters & Experts
- Blue Stake - Instinctive, Longbow, Barebow / Experienced Shooters
- White Stake - Children, Youth, and Inexperienced Shooters
- Shooting may only be done at the designated targets.
- When searching for arrows, a person must remain standing in front of the target in question or indicate the search by leaning the bow against the target or 3D animal.
- Arbitrary modification of the targets, shooting pegs, backstops, and targets at the shooting range is prohibited and punishable.
- Hunting blades and broadheads are not permitted. The use of hunting blades and broadheads is prohibited by the authorities.
- Failure to comply with the rules will result in the immediate revocation of your shooting license.
- We ask that you do not leave any trash behind, as this is the only way this sport can find new friends and interested parties and ensure the continued existence of the facility.
- Any uncertainties or risks that arise must be reported to us immediately! We ask that you please report any other unusual incidents.

TO ALL ARCHERS USING THE COURSE:

Read the course rules carefully – by signing the consent form, you expressly confirm that you have understood and accepted the rules! By adhering to the course rules, each individual contributes to ensuring that this beautiful sport can be practiced for a long time to come!
